#### **DIRECTIONS FOR USE:**

General: SHAKE BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS.

Use **SD HEAVY DUTY** Insect Spray as a spot or crack and crevice treatment to control Ants, Cockroaches, Brown Dog Ticks, Fleas, Cluster Flies, House Flies, Sowbugs, Spiders, Silverfish, Carpet Beetles, Crickets, Millipedes and other insects listed below. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet. Repeat as needed.

## FOR SPOT TREATMENT:

To kill Ants, Cockroaches, Crickets, Silverfish, Spiders, Sowbugs, Earwigs, and Carpet Beetles: Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets, around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat as necessary.

**TO KILL BROWN DOG TICKS AND FLEAS:** Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. DO NOT SPRAY PETS WITH THIS PRODUCT.

## **FLIES AND MOSOUITOES:**

Use only outdoors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when necessary.

## FOR CRACK AND CREVICE:

To kill Ants, Cockroaches, Crickets, Silverfish, Sowbugs, Spiders, Earwigs, Brown Dog Ticks, Fleas, and Carpet Beetles:

Apply spray in small amounts directly into cracks and crevices. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

**STORAGE:** Store in a cool area away from heat or open flame.

**PRECAUTIONS**: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through skin or clothing. May cause skin and/or eye irritation. Avoid contact with eyes, skin or clothing. Avoid breathing vapors. Wash hands after use. DO NOT USE ON HUMANS, PLANTS, ANIMALS, FOOD STUFF, FOOD UTENSILS, OR IN FISHBOWLS OR ANIMAL FEED AREAS. DO NOT USE AS A SPACE SPRAY. **FIRST AID:** If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If ingested, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
