GENERAL INFORMATION

ALGI-BOSS™ is an innovative formulation which provides an excellent control of algae in ponds, dugouts, lagoons and potable water storage tanks.

DIRECTIONS FOR USE

For use in water wholly confined to the property of the user and where there is no outflow beyond the property limits.

DO NOT apply this product in a way that will contact workers or bystanders, either directly or through drift. Only protected handlers may be in the area during application.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

For applications in water destined for use as drinking water, those waters must receive additional and separate potable water treatment. DO NOT apply more than 1.0 ppm as metallic copper in these waters.

DO NOT apply by air.

Ponds, lagoons, dugouts: Apply 1 liter of ALGI-BOSS™ to 60,000 - 600,000 litres of water. Water condition and the extent of active micro-organisms present determine the effective application rate. For permanent algae control maintain 0.5 to 1.0 ppm Cu water. (Add 1.6 ml of ALGI-BOSS™ per 1,000 liters to increase Cu by 0.1 ppm).

Please note that the maximum single application rate of 1 ppm must not be exceeded.

Do not apply or allow discharge to lakes, flowing water or ponds with outflow. Do not apply to areas frequented by wildlife.

Dilution of 1:60,000 (16 ml per 1,000 liters of water) provides 1 part per million (ppm) of a biologically active form of copper (Cu⁺⁺). Use a copper tester to determine existing copper level before adding more ALGI-BOSS™. Please note that the maximum single application rate of 1 ppm must not be exceeded. Do not exceed 1.0 ppm of copper in drinking water.

Warning: This product is toxic to copper-sensitive aquatic plants, invertebrates and fish. When fish are present, special application procedures must be followed. Contact distributor before treating water inhabited by fish.

Commercial use: Where to apply: Product is to be applied for control of algae in industrial and farm ponds. Do not apply or allow discharge to lakes, flowing water or ponds with outflow. Do not apply to areas frequented by wildlife.

Storage: Store in a safe place away from PETS AND KEEP OUT OF THE REACH OF CHILDREN. Store away from excessive heat. ALGI-BOSS™ will freeze. Always keep container closed. Store ALGI-BOSS™ in its original container only. Do not store ALGI-BOSS™ directly on concrete and store above 5°Celsius. Freezing will cause separation.

Handling equipment: Application or storage equipment MUST consist of either fiberglass, PVC's, polypropylenes, viton, most plastics, aluminium or stainless steel. Never use mild steel, nylon, brass or copper around full strength ALGI-BOSS™.

Always rinse equipment free and clean of ALGI-BOSS™ each day with plenty of fresh, clean water. Fabrics containing nylon or cotton will dissolve on contact with full strength of ALGI-BOSS™

DISPOSAL

1. Triple- or pressure-rinse the empty container. Add the rinsings to the treatment site.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
5. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory in case of a spill, and for clean-up of spills.

For recyclable containers (23L or less):

Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collections site:

1. Triple- or pressure-rinse the empty container. Add the rinsings to the treatment site.

ENVIRONMENTAL HAZARDS:

TOXIC to aquatic organisms.

This product is toxic to fish. Direct application of ALGI-BOSS™ to water may cause a significant reduction in populations of aquatic invertebrates, plants and fish. Do not treat more than one-half of a pond at one time in order to avoid oxygen depletion originating from the decaying of the vegetation. Allow one to two weeks between treatments for the oxygen level to recover.

Trout and other species of fish may be killed at application rates recommended on this label, especially in soft or acid waters. Do not contaminate water when disposing of equipment wash waters. (See disposal instructions). Consult the Ministry of Environment before applying this product to public waters. Permits may be required before treating such waters.

FIRST AID

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Eye contact: Contact with eyes may result in permanent visual loss unless removed quickly by irrigation with water.

Ingestion: May be fatal if swallowed.
