READ THE LABEL

PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

Avoid contact with skin, eyes or clothing. In case of contact, immediately flush eyes or skin with plenty of water. Get medical attention if irritation persists. When handling the concentrate, wear full face protection with cartridge respirator and chemical resistant gloves, apron, cap and boots. Use only in well-ventilated areas. Do not wear contact lenses.

DISPOSAL:

FIRST AID:
