This pest control product is to be used only in accordance with the directions on the label. It is an offence under the *Pest Control Products Act* to use this product in a way that is inconsistent with the directions on the label.

FIRST AID

IN CASE OF POISONING, contact a physician or a poison control centre IMMEDIATELY. PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN.

Avoid contact with eyes and skin. Causes painful stinging or burning of eyes and lids. Prolonged contact with skin may cause irritation in some individuals. Wear chemical resistant gloves and face protection (face shield) when handling the concentrate. Do not eat, drink or smoke when using. Wash hands before meals and after work.

STORAGE

Keep in original container tightly closed in a safe place when not in use. Store in a cool and dry location away from oxidizing and reducing agents. Keep away from heat, sparks and sources of ignition. Keep away from food, drink and animal feedstuffs.

SPILL CLEANUP

Eliminate sources of ignition and ventilate area. Soak up spill with absorbent material (kitty litter, granular clay, earth) and collect into a waste container. Wash spill site with water after material pick-up and dispose with waste. See DISPOSAL statement below.

DECONTAMINATION AND DISPOSAL

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean up of spills.

CONTAINER DISPOSAL

FOR DISPOSAL OF PLASTIC JUGS:

Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:

1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
2. Make the empty, rinsed container unsuitable for further use.

If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.

FOR REFILLABLE CONTAINERS:

For disposal, this container may be returned to the point of purchase (distributor/dealer). It must be refilled by the distributor/dealer with the same product. Do not use this container for any other purpose.

If the container is not being refilled, refer to the section FOR DISPOSAL OF PLASTIC JUGS.

SURF SUPREME mixes with all types of water. The rate of SURF SUPREME is indicated for the control product spray mixtures or other uses listed below. Control product spray mixtures, their preparation and uses are to be derived from the individual labels for the control products.
