- A food grade attractant that encourages the insect to ingest the product.

This odourless and non-staining powder can be used without fear of damage to pets, fish, birds and wildlife.

DIRECTIONS FOR USE:

To Control:

INDOORS: Ants, cockroaches, crickets, fleas, silverfish and bedbugs	Gently squeeze or shake the container to lightly coat the areas where insects crawl and hide, especially behind refrigerator and stoves. Rate of application is 50g per 10 square meters of surface area. Hit the insects directly where possible. Repeat treatment as necessary. For bedbugs - disassemble beds and dust mattresses, frames, joints, tufts and seams, floors and baseboards.
OUTDOORS: Ants, centipedes, crickets, earwigs and millipedes	Lightly coat the area where these pests are found or may hide including patios, windows, door frames and sills outside of entrance ways, around foundations and along ant trails. Repeat treatment as necessary.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.

Do not use as a general space spray. Avoid breathing dust. Avoid contact with eyes. Not for direct food contact.

FIRST AID:

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Treat symptomatically.
