**DIRECTIONS FOR USE:**

Rate of use: Lightly coat desired areas using 50 g of King Eco-Way Slug & Snail Killer dust per 10 square meters. For best results use in areas where dust application cannot be affected by heavy rains or high winds. For slugs, earwigs, sowbugs, ants, crickets, millipedes and centipedes, lightly coat areas where these insects are seen or may hide, including around building foundations, window and door sills, patios, porches, along ant trails, around gardens, and under hedges, shrubs and trees.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.**

Do not use as a space spray. Avoid breathing dust. Avoid contact with eyes

**FIRST AID:**

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:**

Treat symptomatically.

**DISPOSAL:**

Dispose of empty container with household garbage. Do not reuse empty container.
