DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

PRECAUTIONS:

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

STORAGE

Do not contaminate water, food, or feed by storage and disposal. Do not store this product near fertilizers, seeds, insecticides or fungicides. Do not store near heat or open flames. Store at room temperature for up to one year from the date of manufacture.
