INDOOR USE

COCKROACHES, EARWIGS, ANTS, SILVERFISH, CRICKETS, MILLIPEDES AND CENTIPEDES: Lightly coat at a rate of 50 grams per 10 m² the areas where these pests are found or may hide such as cracks and crevices, behind and beneath stoves,

refrigerators, sinks, cabinets, garbage cans, around pipes and drains, window frames and in attics and basements. Hit insects directly where possible. Repeat treatment as necessary.

CARPET BEETLES: Thoroughly dust underneath and along edges of carpeting and rugs.

BEDBUGS: Disassemble beds and dust frames, joints, mattresses, tufts and seams, floors and baseboards.

OUTDOOR USE

EARWIGS, ANTS, CRICKETS, MILLIPEDES, AND CENTIPEDES: Lightly coat areas where these pests are found or may hide including patios, windows, door frames and sills, outside of entrance ways, around foundations, and along ant trails. Repeat treatment as necessary.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid breathing dust. Do not use as a space spray. Avoid contact with eyes. Not for direct food contact.

FIRST AID: **If in eyes:** Hold eye open and rise slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. **If on skin or clothing:** take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
