#### **PRECAUTIONS**

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Causes eye irritation. DO NOT get in eyes. May irritate the skin. Avoid contact with skin. Potential skin sensitizer. Harmful if swallowed. Do not inhale vapours. Wash well after handling and before eating, drinking or smoking. Wash contaminated clothing with soap and hot water before reuse. Do not wear contaminated shoes.

When handling concentrate, wear goggles or face shield, chemical resistant gloves (nitrile or neoprene), clean overalls over long-sleeved shirt and long pants, impermeable head covering and chemical resistant boots (rubber) during all mixing/loading activities. Where frequent inhalation of spray mist cannot be avoided, occupational exposure to pesticides can be reduced by use of an air-purifying respirator equipped with an organic-vapor-removing cartridge with a prefilter approved for pesticides (MSHA/NIOSH approval number prefix TC-23C), or a cannister approved for pesticides (MSHA/NIOSH approval number prefix TC-14G), or a NIOSH approved respirator with an organic vapour (OV) cartridge or cannister with any N, R, P or HE prefilter.

## PHYSICAL OR CHEMICAL HAZARDS

**COMBUSTIBLE.** Do not use or store near heat or open flame. Do not weld or cut container.

#### **FIRST AID**

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled**: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If in eyes**: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

# **TOXICOLOGICAL INFORMATION**

The decision of whether to induce vomiting or not should be made by an attending physician. If lavage is performed, suggest endotracheal and/or oesophageal control. Danger from lung aspiration must be weighed against toxicity when considering emptying the stomach. No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient.

Do not ship or store with food, feeds, drugs or clothing.

Do not contaminate irrigation water, lakes, streams or ponds by cleaning of equipment or disposal of wastes.

#### **STORAGE**

Keep in original container during storage. Store product above -2°C in a dry, well ventilated place away from seed, feed, fertilizer or other pesticides. Keep away from fire, open flame or other source of heat.
