### FIRST AID

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call poison control centre or doctor for treatment advice.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

For all cases of human ingestion, immediately notify a physician or poison control centre. If pet or livestock poisoning is suspected, immediately contact a veterinarian. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN, PETS AND LIVESTOCK. May be harmful or fatal if swallowed or absorbed through the skin. Rubber gloves must be worn when handling product and when disposing of dead rodents, unconsumed bait and empty containers. Avoid contact with eyes, skin or clothing. Wash hands before eating, drinking, chewing gum,

using tobacco or using the toilet. Wash skin thoroughly with soap and water after handling. Wash contaminated clothing, separately from other laundry, with soap and hot water before reuse. KEEP AWAY FROM FEED AND FOODSTUFFS. Keep out of lakes, streams or ponds.

**TOXICOLOGICAL INFORMATION:** This product contains petroleum distillates. Vomiting may cause aspiration pneumonia. If swallowed by humans, pets, wildlife or domestic animals, this material may reduce the clotting ability of the blood and cause bleeding. Vitamin K1 in the form of intramuscular or subcutaneous injections, or by oral ingestion are suggested remedial treatments for anticoagulant poisoning. The severity of the case measured by establishing prolonged prothrombin times (P.T.) will determine appropriate therapy. Monitoring P.T. will indicate the necessity of repeated treatments.

**USE LIMITATIONS:** This bait station may be used in indoor areas not accessible to children, consistent with all use restrictions and other requirements indicated on this label. DO NOT USE THIS PRODUCT OUTDOORS OR IN AREAS ACCESSIBLE TO CHILDREN, PETS AND DOMESTIC ANIMALS, OR NON-TARGET WILDLIFE.

This product may only be used to control house mice (*Mus musculus*) indoors. Do not use this product outdoors. Do not place this product in areas where there is a possibility of contaminating food, animal feed, water or surfaces that come in direct contact with food, feed, or water. Do not place station near or inside ventilation equipment or ventilation duct openings.

**SELECTION OF TREATMENT AREAS:** Determine areas where house mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Remove as much alternative food as possible.

**APPLICATION DIRECTIONS:**

**HOUSE MICE:** While wearing rubber gloves, place one bait block in the bait station. Place the bait station at highest point of activity along a wall or in corner where mice or their signs have been seen. If additional units are to be used, place bait stations at 1.5 - 3 metre (5 to 10 foot) intervals. While wearing rubber gloves, replace bait in bait station when bait is consumed or contaminated. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there are no longer signs of new feeding by house mice.

**FOLLOW-UP:** Replace contaminated or spoiled bait immediately. Using rubber gloves collect and dispose of all dead, exposed animals and leftover bait properly. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment.

**STORAGE:** Store in a cool, dry place away from other chemicals and food or feed. Store products not in use, in original container, in a secure location inaccessible to children and non-target animals.

**DISPOSAL:** Wrap used or damaged bait stations and discard in household garbage. DO NOT use damaged bait stations. Dispose of unused bait in accordance with local requirements.

**RODENT DISPOSAL:** Dispose of dead rodents in garbage or by burying.

OPENING THE STATION: 1. Apply rubber gloves. Place station on a hard surface. Position the pushkey in the slot at the front of the closed bait station as shown. With firm downward pressure, push the pushkey straight down into the slot until you hear a click.

2. DO NOT TURN THE PUSHKEY. Holding the base of station with one hand, lift its top holding on the pushkey with your other hand.

3. LOADING THE BAIT: Place bait bar into the station's bait compartment marked "Place Bait Here" as shown. Do not place bait in any other location within the station.

4. CLOSING THE STATION: With downward pressure, push top down until you hear a click.
