DIRECTIONS FOR USE

Kills drain flies/moth flies, fruit flies, phorid flies (including exposed eggs and larvae), house flies, German cockroaches, house crickets, spiders (excluding black widow and brown recluse)*, and springtails on contact.

*Some species of spiders may be less susceptible to TyraTech Drain Fly Killer.

For use indoors and outdoors around commercial, institutional and industrial structures including restaurants, kitchens, hospitals, schools, daycare facilities, hotels, nursing homes, commercial dining rooms, food processing plants, warehouses, lavatories, offices, multi-family housing and veterinary clinics. Product use permitted in other areas or facilities when product is used according to label directions. Do not apply as a space spray. Do not apply more than 1.7 L product/m².

Read entire label prior to use and use product as directed. Product is ready-to-use. Shake product before use. Direct nozzle at target and spray until thorough coverage is achieved. Pests must be sprayed directly with TyraTech Drain Fly Killer to be killed. .
