Use as a spot or crack and crevice treatment to control the insects listed below. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet. Repeat as needed. Provide adequate ventilation after indoor use. Keep pets and children away from sprayed surfaces until dry.

FOR SPOT TREATMENT:

To kill Ants, Cockroaches, Crickets, Silverfish, Spiders, Sowbugs, Earwigs and Carpet Beetles: Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat as necessary.

To kill Brown Dog Ticks and Fleas: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. Do not spray pets with this product.

Flies and Mosquitoes: Use only out of doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas, such as under eaves or porches, patios and garages, where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when necessary. Spray only when air is still and temperature is under 32° C.

FOR CRACK AND CREVICE:

To kill Ants, Cockroaches, Crickets, Silverfish, Sowbugs, Spiders, Earwigs, Brown Dog Ticks, Fleas and Carpet Beetles: Apply spray in small amounts directly into cracks and crevices.
