DIRECTIONS:

SHAKE WELL BEFORE USING.

Aim nozzle at the weed to be treated and spray to wet.

USE PRECAUTIONS:

DO NOT water within 24 hours after application. Rain within 6 hours reduces effectiveness. Spray acts within a few days and weeds gradually die. Grass fills in as weeds disappear. Some weeds may require up to 4 weeks for complete kill. Repeat in 3-4 weeks if necessary. This product is designed to target treatment of weedy areas of lawns.

This product is only effective when applied post emergent to the leaves of actively growing weeds. This product will not prevent new weeds from growing from seed.

DO NOT apply to any body of water.

DO NOT contaminate irrigation/drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Desirable broadleaf terrestrial plants can be harmed by contact with product spray.

DO NOT directly spray or allow the spray to drift onto ornamental plants and trees, fruits, vegetables or exposed roots of trees and ornamentals.

This product may injure bentgrass. DO NOT apply to bent grass turf.

Avoid application of this product when winds are gusty.

DO NOT apply to driveways, sidewalks or any other hard surface.

Turf injury may be observed as tanning or browning of leaf edges, brown patches, or as leaf curling. However, the turf should recover. The application of Clear ChoiceTM Ready-to-Use Selective Herbicide should be carefully directed to the weeds, while minimizing contact with the surrounding turf.

Protective Clothing:

Maximum Application Frequency to Turf:

For good turf/lawn management, normally two applications per year per treatment site are adequate. This product is mainly used as spot treatment and can be used as needed.
