**DIRECTIONS FOR USE:** Shake well. Repels mosquitoes for 5 hours. Also repels black flies, biting midges, deer flies, stable flies, ticks, and chiggers. Apply sparingly not under clothing and only when necessary. Reapply after 5 hours if necessary. Spray into palms and spread evenly on exposed skin. **TO APPLY TO FACE:** Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. DO NOT USE ON CHILDREN UNDER 12 YEARS OF AGE. Causes eye irritation. DO NOT get in eyes. Avoid contact with mouth. Avoid contact with plastic, plants, and fabrics such as rayon, dynel, and acetate. May damage furniture finish, plastics and painted surfaces. Keep away from open flame or spark. Do not contaminate food, utensils or any body of water.

**FIRST AID:** If in eyes: hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Have person sip a glass of water if able to swallow. Do not give anything by mouth to an unconscious person. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** Do not re-use container. Dispose of empty container in household garbage.
