DIRECTIONS FOR USE

For best results apply in sunny, warm weather to actively growing young weeds less than 10 cm tall. No dilution or mixing is required. For most applications, use a coarse spray to wet only unwanted foliage. Complete coverage is necessary for best results.

To control top growth of dandelion and plantain in lawns, use a coarse spray and contact only the weed. Hold the container close to the weeds. Control the spray pattern so that only the centre of the weed is contacted. Grass that is sprayed will also be burnt but regrowth will occur. Weeds that are mature, dormant or hardened due to moisture stress tend to be more tolerant to herbicide treatments. Retreatment of large weeds and regrowth of perennial weeds may be required. Only vegetation is that contacted will be controlled.

READY TO USE, FAST ACTING:

This is a fast acting product for non-selective vegetation control and spot treatment of individual weeds. Visible effects occur after treatment, and actively growing susceptible weeds are controlled within 1-2 days. Leaves no harmful residue in the soil.

TURF REVOLUTION WEED KNOCK-OUT LIQUID HERBICIDE is recommended for control of undesirable plants in and around gardens, on patios, sidewalks, driveways,

under fences and around established trees and shrubs. Use to edge along driveways, sidewalks and to control weeds in gravel and mulch.

TURF REVOLUTION WEED KNOCK-OUT LIQUID HERBICIDE application results in rapid burn down and control of the following annual weeds: common ragweed, chickweed, black medic and lamb's-quarters and top growth control of the following perennial weeds: dandelion, plantain (broadleaved and narrowleaved), wild carrot and quackgrass.

CAUTION. Avoid contact on desirable plants. Overspray or drift will injure contacted vegetation.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. Corrosive to the eye. DO NOT get in eyes. Avoid contact with skin and clothing. Wash immediately after use. Avoid all contact with desirable plants. Overspray or drift will injure contacted foliage. Avoid application to reactive metals such as aluminum, tin, iron, or items such as fencing or lawn furniture in order to prevent staining, mottling, or otherwise interfering with finished metal surfaces. WEAR SAFETY GOGGLES during application. Avoid spraying on windy days.

FIRST AID

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

STORAGE
