Also repels black flies. Apply sparingly not under clothing and only when necessary. Reapply after 2 hours if necessary. Hold container upright and spray clothing and exposed skin, except face. TO APPLY TO FACE: Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not contaminate food, utensils or any body of water. Supervise applications on children. Do not use on infants under 6 months of age. In 6 month to 2 year olds, do not apply more than once a day. Not for daily use. Avoid application to hands. In 2-12 year olds, do not apply more than 3 times per day. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If irritation or other adverse effects develop, wash with soap and water immediately. Seek medical attention if symptoms persist.
