## **DIRECTIONS FOR USE:**

For best results apply in sunny, warm weather to actively growing young weeds less than 10 cm tall. No dilution or mixing is required.

## READY TO USE, FAST ACTING:

This is a fast acting product for non-selective vegetation control and spot treatment of individual weeds. Visible effects occur after treatment, and actively growing susceptible weeds are controlled within 1-2 days. Leaves no harmful residue in the soil.

Green Earth® Weed & Grass Killer is recommended for control of undesirable plants in and around the garden, on patios, sidewalks, driveways, under fences and around established trees and shrubs. Use to edge along driveways, sidewalks and to control weeds in gravel and mulch.

Green Earth® Weed & Grass Killer application results in rapid burn down and control of the following annual weeds: common ragweed, chickweed, black medic and lamb's quarters and top growth control of the following perennial weeds: dandelion, plantain (broadleaved and narrowleaved), wild carrot and quackgrass.

Apply with the hand trigger sprayer attached. Depress button top and adjust nozzle to suitable spray pattern. For most applications, use a coarse spray to wet only unwanted foliage. Complete coverage is necessary for best results.

To control top growth of dandelion and plantain in lawns, use a course spray and contact only the weed. Hold the container close to the weeds. Control the spray pattern so that only the centre of the weed is contacted. Grass that is sprayed will also be burnt but re-growth will occur. Weeds that are mature, dormant or hardened due to moisture stress tend to be more tolerant to herbicide treatments. Retreatment of large weeds and re-growth of perennial weeds may be required.

Only vegetation that is contacted will be controlled.
