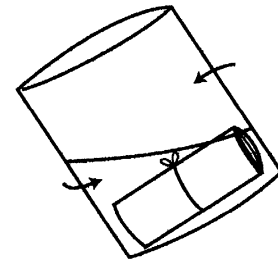
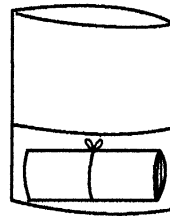
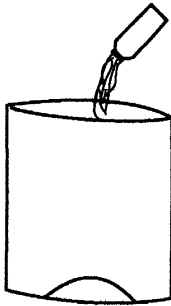
Procedure for Treating Military Combat Clothing with insect/Arthropod Repellent Protective Treatment

BAG A - COAT



1. Lay coat flat, fold sleeves across front, fold shoulder to shoulder (A) and roll tightly (B). Tie middle of roll tightly with string (C).

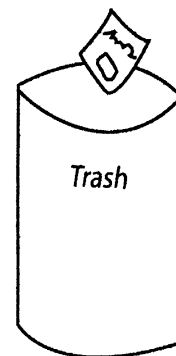
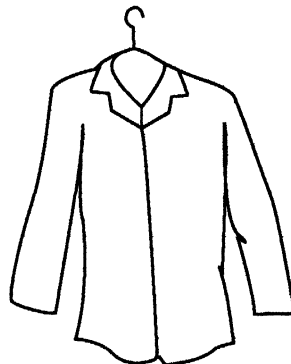
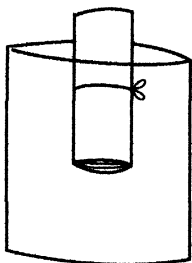
2. Place 450 mL (16 ounces) of clear water into bag.



3. Wearing chemical resistant gloves, empty contents of one Permethrin bottle into bag, drop bottle and cap into bag. Hold upright and gently shake two times to mix.

4. Place rolled coat into bag and zip lock.

5. Gently shake bag 2 times and then let rest at least 3 hours.



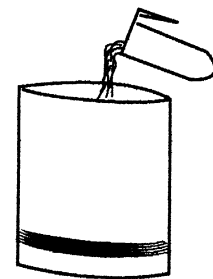
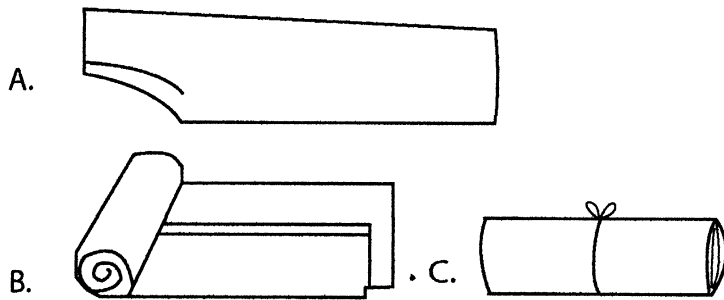
6. Unzip bag and remove roll.

7. Untie string and hang coat for 3 hours or until dry and coat is ready to wear. Mark "Permethrin Treated" and the date inside the collar.

8. Place used bags, string, bottles in one ziplock bag and put in designated trash receptacles.

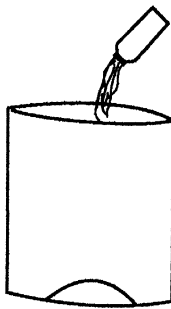
BAG B - TROUSERS



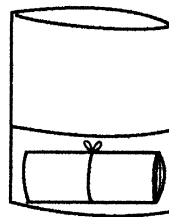

1. Lay trousers flat, fold leg to leg (A) and roll tightly (B). Tie middle of roll tightly with string (C).

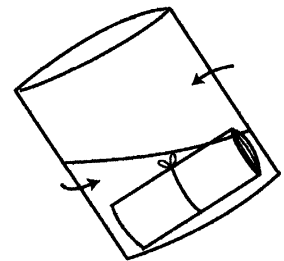
2. Place 450 mL (16 ounces) of clear water into bag.



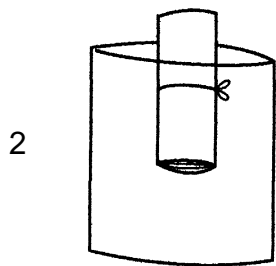
3. Wearing chemical resistant gloves, empty contents of one Permethrin bottle into bag, drop bottle and cap into bag. Hold upright and gently shake two times to mix.



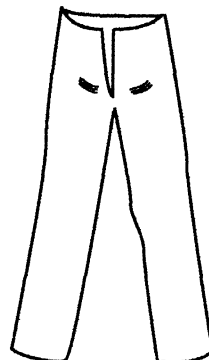
4. Place rolled trousers into bag and zip lock.



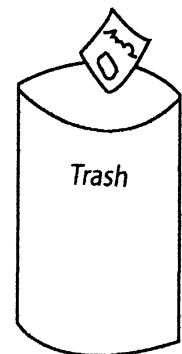
5. Gently shake bag 2 times and then let rest at least 3 hours.



6. Unzip bag and remove roll.



7. Untie string and hang trousers for 3 hours or until dry and trousers are ready to wear. Mark "Permethrin Treated" and the date inside the waste band.



8. Place used bags, string, bottles in one ziplock bag and put in designated trash receptacles.

DIRECTIONS FOR USE: Treated uniform provides protection to covered areas of the body from mosquitoes and ticks. **Insect/Arthropod Repellent Protective Treatment for Military Combat Clothing (i.e. permethrin pouch) is not to be used in conjunction with any other insect repellent clothing treatments. Treatment to be performed in well ventilated area.**

Application Procedure: Place 450 mL (16 ounces) of clear water into bag. Wearing chemical resistant gloves, pour contents of 1 bottle of permethrin into bag. Zip lock bag and shake 2 times to mix. Unzip bag, place rolled and tied coat or trousers in bag. Zip lock, shake 2 times and let stand 3 hours or more. Unzip bag, remove garment and hang for 3 hours or until dry. When dry, garment is ready to wear. Mark with indelible ink on the label of clothing item "Permethrin Treated" and the date of the treatment. **DO NOT RE-TREAT CLOTHING UNLESS DIRECTED TO DO SO BY THE APPROPRIATE MILITARY AUTHORITY;** treated clothing will maintain its effectiveness against mosquitoes through about 50 washes and against ticks through about 25 washes. **DO NOT TREAT UNDERWEAR OR HEAD GEAR. WHERE REQUIRED AND UNDER APPROPRIATE MILITARY DIRECTION, DRY CLEANING CAN BE USED TO REMOVE PERMETHRIN FROM TREATED UNIFORMS.**
