This product prevents eggs from fleas on treated cats from developing into biting adults for up to three months. As with all flea control products, Sergeant's PreTect Squeeze-On Flea Control for Cats and Kittens should be used as a part of a program aimed at reducing flea populations in the pet's environment (bedding, carpet). For existing flea infestations, a premise treatment including an adulticide and larvicide should be used prior to treating your pet with Sergeant's PreTect Squeeze-On Flea Control for Cats and Kittens.

### **PRECAUTIONS:**

**PHYSICAL AND CHEMICAL HAZARDS:** Flammable liquid. Do not store near heat or open flame.

**HUMANS: KEEP OUT OF THE REACH OF CHILDREN**. Severely irritating to the eyes. DO NOT get in eyes. Avoid contact with clothing. Wear rubber gloves when handling. #### Do NOT administer by mouth.

FOR USE ON CATS AND KITTENS OVER 12 WEEKS OF AGE. Do NOT use on cats or kittens under 12 weeks of age. DO NOT USE ON OTHER ANIMALS. Treatment must only be repeated if pest problem reoccurs.

This product is packaged in single dosage tubes. Apply one 1.5 mL tube to cats and kittens over 12 weeks of age. Do not apply at a rate higher than the recommended dosage. For continual pest control in situations where there is an ongoing risk of pest infestation, repeat application in 3 months (90 days) for cats and kittens 4 kg or less in weight, and repeat application in 2.5 months (75 days) for cats over 4 kg in weight. Wrap tube and put in trash.
