DIRECTIONS:

Apply sparingly, not under clothing and only when necessary. For best results, spread evenly with hand to moisten all exposed skin. Do not spray directly on face. To apply to face, dispense on palm of hand and spread on face and neck. Reapply once as needed. Do not apply more than twice per day.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. DO NOT use on children under 3 years of age. Causes eye irritation. DO NOT get in eyes and avoid contact with mouth. Harmful if swallowed. Discontinue use if signs of irritation or rash appear. Store at room temperature. COMBUSTABLE. Keep away from heat or open flame. Do not expose to temperatures above 50°.
