## **DIRECTIONS FOR USE**

To be used only in the manufacture of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

## **PRECAUTIONS**

### **PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.**

Strictly observe all precautions for handling and using pesticides. May irritate the skin. Avoid contact with skin, eyes and clothing. Do not contaminate food, feed or water supplies. ## **FIRST AID:**

## **TOXICOLOGICAL INFORMATION**

There is no specific antidote, if this product is ingested. Treat symptomatically. If a large amount has been ingested and emesis is inadequate, lavage stomach. An aqueous suspension of activated charcoal can be administered to absorb remaining toxicant.
