DIRECTIONS FOR USE

Drain tank and clean periodically. When refilling the tank add 5 milliliters of Essick Air Humidifier Bacteriostatic Treatment for every 4 liters of water. Repeat the process when refilling the tank.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN

Wear rubber gloves when handling this concentrate. Harmful if swallowed. Do not mix with any other chemical. Avoid contact with skin and eyes.

FIRST AID

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Treat symptomatically.

DISPOSAL:

Do not re-use empty container. Wrap and discard empty containers in household garbage.
