DIRECTIONS FOR USE

To be used only in the manufacture of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

FIRST AID
