# DIRECTIONS FOR USE

DO NOT apply when swimmers are in the immediate vicinity (a 15-minute restricted-entry interval is recommended.)

1. Initial dosage for pool water having no visible algae is 400 ml of Pool Pure Algaecide 5 per 10,000 L of pool water.

- 2. Weekly maintenance dosage is 200 ml per 10,000 L.
- 3. For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait for at least 24 hours before adding weekly maintenance dosage.
- 4. For visible algae, when superchlorination is not employed, add 1 L of Pool Pure Algaecide 5 per 10,000 L.

## PRECAUTIONS
