DIRECTIONS FOR USE: TANK MIX WITH ATRAZINE. ADAMA 8317 OIL CONCENTRATE is a blend of light agricultural spray oil and a surfactant that is especially suited for use with AATREX 480 LIQUID HERBICIDE. When ADAMA 8317 OIL CONCENTRATE is added to the spray mixture, the post emergence activity of AATREX 480 LIQUID HERBICIDE may be improved, particularly on quackgrass, nutgrass and annual grasses such as green and yellow foxtail and barnyard grass. The period of application may also be extended for broadleaf control. ADAMA 8317 OIL CONCENTRATE plus AATREX 480 LIQUID HERBICIDE has given satisfactory control of broadleaf weeds up to 10 cm high.
