DIRECTIONS: Shake well. Open top cap. Holding bottle at 45-degree angle, powder should flow freely when squeezed.

INDOOR USE: [EARWIGS] [ANTS] [COCKROACHES] [SILVERFISH] [CRICKETS] [MILLIPEDES] [CENTIPEDES]. Lightly coat at a rate of 50 grams per 10 m<sup>2</sup> the areas where [ants] [cockroaches] [earwigs] [silverfish] [crickets] [millipedes] [centipedes] [these pests] are found or may hide such as cracks and crevices, behind and beneath stoves, refrigerators, sinks, cabinets, garbage cans, around pipes and drains, window frames and in attics and basements. Lightly coat the area where these pests are found and may hide including ant hills and trails, around foundations, window frames, door sills, patios, garages, sheds, outside entrance ways and cracks and crevices. PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid breathing dust. Do not use as a space spray. Avoid contact with eyes. Not for direct food contact.
