DIRECTIONS FOR USE

To be used only in the manufacturing of a herbicide which is registered under the *Pest Control Products Act*.

PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Avoid contact with skin, eyes and clothing. Wash immediately after use. **WEAR PROTECTIVE EYE GLASSES** during production and handling.

FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

Treat symptomatically.

STORAGE

Do not contaminate water, food or feed by storage or disposal. Keep from freezing. Store only in original tightly sealed container and out of reach of children. Keep away from oxidizers, heat or flame.
