DIRECTIONS FOR USE

Antifungal Additive for Flexible Vinyl Products:

To be used where the finished product is exposed to conditions conducive to decay.

For protection of flexible vinyl products such as roof membranes, swimming pool liners, awnings, marine upholstery, interior wall covering, flooring, and shower curtains against microbial deterioration.

Use 0.8% to 2.0% of this product, based on the total weight of the plastic compound during the mixing step. Pre-blending into liquid plasticizers for easier mixing can be helpful. This treatment has been shown to be effective for a period of 24 months in well stabilized flexible PVC articles. The duration of protection is dependent upon exposure conditions and the flexible vinyl formulation. In order to determine the most effective use level for this product in a given use, trials are suggested within the label rates.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN

CORROSIVE TO EYES AND CAUSES SKIN IRRITATION

POTENTIAL SKIN SENSITIZER

DO NOT get in eyes, on skin, or on clothing. Do not swallow. Wash skin thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

Wear coveralls over long sleeved shirt and long pants, chemical resistant gloves, socks, chemical resistant footwear and a full face NIOSH-approved respirator during mixing, loading, application, clean up and repair.

FIRST AID

IF ON SKIN OR CLOTHING:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF IN EYES:

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF INHALED:

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration,

preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
