Hold container upright, 15-20 cm away, and spray clothing and exposed skin except face. TO APPLY TO FACE: Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces. Wash hands after applying.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not spray near open flame or spark, or while smoking. Do not contaminate food, utensils or any body of water.
