Loosen outer rings of coil until end moves freely. Grasp each comma-shaped portion in the center between thumb and forefinger of each hand. Separate the two comma-shaped coils by gently pressing them in opposite directions 5 mm apart. Hold one comma shaped end and shake lightly or gently pry apart to separate the coils. Place (one coil per 9 m2 in area / coils 2-3 m apart around area / 3-4 coils about 3 meters apart around area) where mosquitoes are to be repelled. **DO NOT** use in windy areas. Use in outdoor areas, including backyards, patios, porches and decks, which are sheltered from effects of wind and more easily protected by coils. (In light winds, place coils upwind where possible to make use of associated drift. If shorter periods of use are desired, break coil into appropriate lengths and place in notched cut-out of holder.) One coil will burn for approximately 5 hours.
