DIRECTIONS FOR USE:

To be used only in the manufacture of a herbicide which is registered under the Pest Control Products Act.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Highly CORROSIVE to the eye and skin. DO NOT get in eyes, on skin or on clothing. Fatal if swallowed or inhaled. DO NOT inhale/breathe vapours, fumes or smokes. Handling of the

product must be done in a well-ventilated area. Use full face shield with goggles. Wear cuffed butyl rubber gloves, slicker suit and rubber boots when handling. Use a NIOSH approved vapour respirator under emergency conditions.

FIRST AID:

If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. call a poison control centre or doctor for treatment advice.

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

STORAGE:
