HANDLING

During mixing, loading, application, spill cleanup and sprayer clean-up, maintenance or repair, wear a long-sleeved shirt, long pants and chemical resistant gloves. Avoid contact with eyes, skin and clothing. Wash thoroughly with soap and water after handling. Avoid breathing spray mist. Store away from food or feed. Do not contaminate water supplies, wetland areas, or any body of water by direct application, spray drift or when cleaning and rinsing spray equipment or containers.

RE-ENTRY

Workers should not enter treated fields within the period of re-entry time stated on the Ladder 240 EC Herbicide labels applied in conjunction with ADAMA ADJUVANT 80.

FIRST AID IF SWALLOWED:

Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION

Treat symptomatically.

STORAGE

Store in a cool, dry and well-ventilated area. Keep in original container tightly closed in a safe place when not in use. Keep away from food, drink and animal feedstuffs.

SPILL CLEANUP

Soak up spill with absorbent material (kitty litter, granular clay, soil) and collect into a waste container. Wash spill site with water after material pick-up and dispose with waste. See disposal statement below.
