# PRECAUTIONS PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

May cause irritation of nose, throat, eyes and skin. Avoid contact with skin, eyes and clothing. Do not breathe dust. May be harmful if swallowed or inhaled or absorbed through skin.

Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

## **FIRST AID**

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes: Hold eyes open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

#### STORAGE AND DISPOSAL

If spilled during storage or handling sweep

Decomposition produces foul odor due to formation of toxic, flammable gases; if observed, check for hot containers and remove immediately to open areas for disposal.
