# Malathion liquid insecticide-miticide concentrate

#### **DIRECTIONS FOR USE:**

For outdoor use only.

Avoid application of this product when winds are gusty.

DO NOT apply to any body of water.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

#### DIRECTIONS FOR USE: VEGETABLES, FRUITS, FLOWERS AND ORNAMENTALS:

to control aphids, bagworm, beetles, budmoth, cabbage worm, caterpillars, codling moth, currant fruitworm, fruit moth, lace bug, leafhopper, leafminer, leafroller, mealybug, mites, pine shoot moth, pear psylla, plant bug, plum curculio, potato beetle, raspberry fruitworm, tent caterpillars, whitefly.

Mix 10 ml (2 teaspoonfuls) in 3 L of water and spray to wet all surfaces of foliage. Apply at first appearance of insects. Repeat applications as required or at 7 day intervals. Do not apply within seven days of harvest of edible crops. Leaf lettuce within fourteen days. For spruce budworm apply at 20 ml (4 teaspoonfuls) in 3 L of water as soon as larvae appear.

Injury may occur to African violet, crassula, fern, petunia, Sabina and Canaerti juniper, red maple, McIntosh and Courtland apples, Bosc and Bartlett pears, and Ribier grapes.

Clover mites Ants and Millipedes: OUTDOOR STRUCTURAL FOUNDATIONS ONLY and 1 metre path around buildings: Mix 60 mL (4 tablespoons) in 1 Litre of water and spray exterior walls and surrounding buildings.

**Mosquitoes**: Mix 20 mL (4 teaspoons) in 3 Litres of water and spray on 40 m<sup>2</sup> on shrubs.

Isomalathion, a toxic metabolite of malathion forms when malathion product is stored at elevated temperatures or for extended periods of time. Malathion product must be stored in a cool (< 23°C), dry, well ventilated place away from seed, fertilizer or other pesticides. **Do not use after the expiry date.**
