Treatment must only be repeated after 7 days if pest problem persists or reoccurs. Use with caution on new growth and on tender young plants and foliage. ### Use Limitations

**To kill** Thrips, Leafhoppers, Spotted mites, Lace bugs, Aphids, (Adult) Whiteflies, Climbing cutworms, Japanese beetles, Flea beetles, Armyworms **on pear trees, tomatoes, beans, grapevines and the following ornamental plants:** Asters, Azaleas, Begonias, Chrysanthemums, Dahlias, Delphiniums, Gladiolas, Irises, Marigolds, Petunias, Roses, and Snapdragons, Evergreens, Small deciduous trees, Shrubs and Vines: When listed pests (are a problem/first appear), spray to thoroughly cover all foliage, including upper and lower leaf surfaces until damp. **DO NOT** wet plants to the point of runoff or drip. When spraying, hold can 30-45cm from plants to avoid wetting the foliage.) Apply in early morning or evening – not in direct sunlight. Spray only when air is still and temperature is below 32°C.

**STORAGE:** CONTENTS UNDER PRESSURE **DO NOT** place in hot water or near radiators, stove or other sources of heat **DO NOT** puncture or incinerate can or store at temperatures over 50°C. **DO NOT** spray into or near any open flame or spark, or while smoking. Store this product away from food or feed.
