DIRECTIONS FOR USE:

To be used only in the manufacture of a herbicide which is registered under the *PEST CONTROL PRODUCTS ACT* or a fertilizer-pesticide registered under the *FERTILIZERS ACT*.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful if swallowed. May cause skin and eye irritation. Avoid contact with skin, eyes or clothing. Wear protective goggles and gloves when handling. Wash hands and exposed skin thoroughly after handling.

FIRST AID:

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. .

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison center or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

No specific antidote. Employ supportive care. Treatment should be based on judgement of the physician in response to reactions of the patient. This product may cause severe irritation to the eyes. Overexposure to 2,4-D may cause coughing, burning, dizziness or temporary loss of muscle coordination. Other possible effects of overexposure include fatigue, muscle weakness or nausea. Treat symptomatically.

DISPOSAL:

Canadian manufacturers using this product should dispose of unwanted active ingredient and containers in accordance with municipal or provincial regulations. For additional details and clean up of spills, contact the manufacturer or the provincial regulatory agency.

SPILLAGE CLEANUP:

Keep bystanders away. Do not smoke, drink or eat during clean-up operations. Wear protective equipment (respirator, coveralls, rubber boots and protective gloves), and absorb the liquid onto soil, sawdust or other suitable absorbent material and shovel into a drum. Add broken packages to the drum and seal for removal to an approved disposal site. Remove and wash all protective clothing and equipment. Shower and wash thoroughly with soap and water on completion of mopping up operation. For details on spill cleaning contact the provincial regulatory agency or the manufacturer.
