face. TO APPLY TO FACE: Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

PRECAUTIONS: Keep out of reach of children. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat or store at temperatures over 50C. Do not spray near open flame or spark, or while smoking. Causes eye irritation. DO NOT get in eyes. Avoid contact with mouth.
