Note: DWP-962 is inc ompatible with 2-mercaptobenzothiazole, a component of some corrosion inhibitors.

DWP-962 concentrate can be corrosive for copper, brass, mild steel, cast iron and zinc. Equipments used to dispense DWP-962 concentrate (e.g., pumps, piping, containers) containing these metals should be avoided.

OILFIELD OPERATIONS

DWP-962 is effective in controlling problematic bacteria encountered in oilfield applications. It is use d to control sulphate reducing bacteria (SRB) and general heterotrophic bacteria, such as Pseudomonas species. DWP-962 is used in water flo od (water injection) applications whereby it controls bacterial growth wit hin the injection system and within the rock matrix of the hydrocarbon reservoir.

Dosing of DWP-962 in Water Floods:

Heavily fouled systems must be cleaned before treatment.

Dosing Point: DWP-962 must be added continually via an injection pump, to the injection syst em either immediately before or after the de-aerator, which is usually the primary source of contamination.

Initial Dose: Based on the water injection volume, shot dose DWP-962 at a maximum of 330 mg of product per litre of water for 1 to 3 hours. Follow directions for maintenance doses afterwards.

Maintenance doses: Dose continuously at a conce ntration of up to 55 mg of DWP-962 per litre of water injected.
