Hold container upright, apply sparingly, not under clothing and only when necessary. Reapply after 2 hours if necessary. **TO APPLY TO FACE OF ADULTS AND INDIVIDUALS OLDER THAN 12 YEARS OF AGE:** Spray hands and apply avoiding eyes and mouth. Wash hands, after application.
