FOR USE INSIDE AND AROUND THE EXTERIOR OF HOMES, APARTMENTS AND MOBILE HOMES.

ATTRACTS AND KILLS COMMON SWEET-EATING ANTS.

USING TERRO® ANT KILLER:

Apply as a spot or crack and crevice application only. A spot application is an open, localized placement of bait in areas inaccessible to children and pets. Locations of treatment may include under sinks and heavy appliances (e.g., fridge or stove). Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and moldings. Ants typically follow defined trails from the nest to food or water. Placing TERRO® Ant Killer on building surfaces close to these trails or where ants are seen will improve control.

Indoors: For spot application, place small pieces of this product's packaging (simply tear pieces from the carton along the perforated lines), waxed paper or tinfoil in an area inaccessible to children and pets. On each piece of product packaging, waxed paper or tin foil, apply a few drops of TERRO® Ant Killer. For crack and crevice application, apply a few drops directly in the cracks where ants are seen or at the entrance to the nest. Monitor the placements and ensure there is always a fresh supply of TERRO® Ant Killer on each placement.

Outdoors: Invading ants may have outdoor nesting sites. Place small pieces of product packaging, waxed paper or tin foil onto building surfaces close to where ants are found entering the structure (e.g., windows and doors) in an area inaccessible to children and pets. On each piece, apply a few drops of TERRO® Ant Killer. Monitor the placements and ensure there is always a fresh supply of TERRO® Ant Killer on each placement.

CONTROLLING ANTS: At first, ants will come to the bait in large numbers, but then will gradually disappear. TERRO® Ant Killer allows worker ants to live long enough to carry the bait back to the colony. The entire colony is usually killed within two weeks. The key to obtaining control is to monitor the placements and ensure there is always a fresh supply of TERRO® Ant Killer at each placement.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN AND PETS. May irritate eyes. Avoid contact with eyes. Potential skin sensitizer. DO NOT apply to animals. Avoid contamination of food, water and kitchen utensils. Do not apply to food or food packaging. Wash after use. DO NOT apply when people or pets are present.

FIRST AID: If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious

person. If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing the eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: Do not reuse empty containers. Wrap in newspaper and dispose of empty containers in household garbage.
