**PRECAUTIONS**  
**PREVENT ACCESS BY UNAUTHORIZED PERSONNEL**

**Danger – eye irritant.** Avoid contact with eyes. Workers should wash hands before eating, drinking, chewing gum, using tobacco or the toilet.

**PROTECTIVE CLOTHING AND EQUIPMENT**  
Use chemical workers' goggles and wear clean body covering clothing.

**FIRST AID**

**If swallowed,** call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. **If on skin or clothing,** take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **If inhaled,** move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. **If in eyes,** hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION**

No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient.
