**DIRECTIONS FOR USE:**

Nuosept® 498G Preservative is an effective in-can preservative in the following aqueous compositions.

Application ranges or use concentrations based on the total weight of product are as follows:

USE	Amount* of Nuosept® 498G Preservative based on Total Weight of Product
Latex Emulsions	0.03 to 0.075 %
Aqueous Based Paints	0.03 to 0.25 %
Metal Working Fluids	0.015 to 0.25 %
Aqueous Mineral Slurries	0.04 to 0.25 %

**\*The optimum amount, within the above range of rates of Nuosept® 498G Preservative, that is required for adequate preservation is best determined by actual tests.**

**PRECAUTIONS:**

KEEP OUT OF REACH OF CHILDREN.

CORROSIVE. POTENTIAL SKIN SENSITIZER.

Causes severe eye and skin damage.

Do not get in eyes on skin or on clothing.

Wear goggles or face shield when handling.

Wear a long-sleeved shirt, long pants and chemical-resistant gloves when handling this product.

Harmful or fatal if swallowed.

Avoid contamination of food.

**FIRST AID:**

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
