DIRECTIONS FOR USE

TO BE USED ONLY BY TECHNICALLY QUALIFIED PERSONS.

POLYMER LATEX PRESERVATION

This product is recommended for the control of bacteria and fungi in the manufacture and storage of synthetic and natural polymer lattices. Add 0.02% of this product to provide 100 ppm active ingredient. To insure uniform distribution, slowly disperse this product into product with agitation. Mix thoroughly until evenly dispersed throughout product.

This product weighs 1.1623 kilograms per litre

METALWORKING FLUID PRESERVATION – TANKSIDE ADDITION

This product is recommended for the control of bacteria and fungi in water-extendible metalworking fluids (soluble oil, semi-synthetic and synthetic types). The preservative should be dispensed as a tankside additive into the circulating use-dilution of the metalworking fluid using a metering pump or by manual pouring, and uniformly dispersed throughout the system. Dose this product at 0.015% - 0.03% (75 to 150 ppm active ingredient) every 1-6 weeks.

METALWORKING FLUID CONCENTRATES

This product is recommended for the control of bacteria and fungi in water-extendible metalworking fluids (soluble oil, semi-synthetic and synthetic types) when added to the metalworking fluid concentrates. This product should be added to the concentrate at a level to ensure that the final use-dilution metalworking fluid will contain this product at 0.015% - 0.03% (75 to 150 ppm active ingredient).

It is recommended the formulator test within the range of rates on the label to determine an effective rate for their specific product.
