DIRECTIONS FOR USE: Apply sparingly, not under clothing and only when necessary. **TO APPLY TO FACE:** Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces. Reapply after 7 hours if necessary for protection from mosquitoes and 8 hours if necessary for protection from ticks.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Supervise applications on children. Do not apply to the hands of small children. Do not use on infants under 6 months of age. Avoid contact with mouth. Causes eye irritation. **DO NOT** get in eyes.

FIRST AID: If irritation or other adverse effects develop wash with soap and water immediately. Seek medical attention if symptoms persist. **If in eyes:** hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do NOT induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. **If inhaled,** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: Do not reuse empty container. Wrap and dispose of empty container with household garbage.
