FIRST AID

TOXICOLOGICAL INFORMATION

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. Avoid contact with skin, eyes and clothing. Avoid inhalation of spray. Wash after using. When spraying indoors cover fish bowls and remove pets for one hour. Remove or cover all exposed foods and cooking utensils before spraying. **DO NOT** use on Maiden Hair Ferns. Toxic to birds. Toxic to aquatic organisms. **DO NOT** apply using handheld or stationary fogging or misting equipment. **DO NOT** apply as a space spray. Space spray: Space application is a suspension of fine droplets (0.1 to 100µm) in the air.

- Apply with the hand trigger sprayer attached. Depress button on top and adjust nozzle to suitable spray pattern.

FOR USE ON INDOOR ORNAMENTAL HOUSEPLANTS AND GREENHOUSE ORNAMENTAL PLANTS

To kill Whiteflies, Spider mites, Aphids **on** African violet, Asters, Azaleas, Begonias, Camellias, Carnations, Chrysanthemums, Crassula, Dahlia, Delphiniums, Dogwood, English ivy, Euonymus, Fuschia, Geraniums, Gladioli, Kentia palm, Laurel, Marigold, Rhododendron, Rose, Rubber plant, Snapdragon, Stock, Wandering Jew and Zinnia: **DO NOT** apply to plants grown for food or feed (e.g., fruits, vegetables, herbs). **DO NOT** use in commercial greenhouses. When listed pests first appear, spray to thoroughly cover all foliage,

including upper and lower leaf surfaces until damp. **DO NOT** wet plants to the point of runoff or drip. When spraying, hold container 30-45 cm from plants to avoid wetting the foliage. To enhance effectiveness of this product, apply directly to the listed pests where possible. **DO NOT** exceed 160 mL per m². Treatment must only be repeated after 7 days if pest problem persists or reoccurs. Use with caution on new growth and on tender young plants and foliage. Test on one or two leaves to determine safety. **DO NOT** spray in direct sunlight. Spraying in early morning or in the evening is preferred. Spray when air is still and temperature is below 32°C.

STORAGE

Store this product away from food or feed.

DISPOSAL

DO NOT reuse the empty containers. Dispose in household garbage. Unused or partially used products should be disposed at provincially or municipally designated hazardous waste disposal sites.
