### **DIRECTIONS FOR USE**

To be used only for the manufacturing of industrial microbicides which are registered under the *Pest Control Products Act*.

Formulators are responsible for their own registrations under the *Pest Control Products Act*.

#### **PRECAUTIONS**

#### PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

Harmful if swallowed. Avoid breathing vapor. Avoid contact with eyes, skin, clothing and the contamination of food. Wear coveralls over long sleeved shirt and long pants, goggles or faceshield, chemical-resistant gloves, socks and chemical-resistant footwear during mixing, loading, application, clean-up and repair. Wear a cartridge respirator if the area is not well ventilated and during clean-up, maintenance, and repair activities. Wash hands and face before eating, drinking, smoking, and using the toilet. Keep the container closed when not in use. DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

#### **FIRST AID**

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**TOXICOLOGICAL INFORMATION:** Note to physician: Probable mucosal damage following ingestion may contraindicate gastric lavage. Avoid alcohol or alcohol related products. Treat symptomatically.
