CONTINUOUS KILLING ACTION FOR 60 DAYS

For use as a spot or crack and crevice treatment to control Ants plus Cockroaches, Earwigs, Spiders, Sowbugs, Silverfish, Dog & Cat Fleas, Brown Dog Ticks & House Flies.

GENERAL DIRECTIONS: SHAKE CAN WELL BEFORE USING. Test a small inconspicuous area of the surface to be treated for color fastness & staining before full application. Do not apply to draperies, wallpaper or similar materials that may be stained. Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vaporize into cracks and crevices for insect control. If reinfestation occurs, repeat applications as necessary. Unpainted or unsealed concrete surfaces may require repeated application after two weeks if necessary. Provide adequate ventilation after indoor use. **KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY.**

INDOOR & OUTDOOR USE: Thoroughly treat cracks, crevices and spots along and behind baseboards, underneath furniture and equipment, around garbage containers, localized areas of floors and floor coverings and other places where insects hide or are seen. **Spot Treatment for House Flies:** Spray spots on surfaces of screen frames, doors, window frames, foundations, patios, light fixtures and other places where insects may alight, or congregate and enter. The insects will be killed when they land and crawl on the treated surfaces. **Crawling Insects:** Spray hiding places such as baseboards, moist areas, openings around sinks, drains and pipes, behind cabinets and storage areas. Spray ant trails, around door sills, window frames, or in ant nests. Do not use in food storage areas or on surfaces that may contain food. **To Control Fleas & Brown Dog Ticks:** Spray infested areas such as pet's bed and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor covering where these pests may be present. Remove old bedding after treatment. Insects must be contacted to be killed. Do not treat animals with this product.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Does not use as a space spray. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50°C. Cover fish bowls and remove pets for one hour when spraying rooms. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying. After use, wash all surfaces that may contact food. Avoid contact with skin, eyes, clothing. Avoid inhalation of spray. Wash after using. Keep from freezing. Do not use on Maiden Hair ferns.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically. Contains petroleum distillates.

DISPOSAL: When container is empty, press button to release all pressure then dispose in household garbage. Do not puncture or incinerate.
