### DIRECTIONS:

This product is for use indoors in dwellings (homes/individual apartments). Zone Guard, Pro Ant, Roach & Crawling Insect Blaster provides fast knockdown and flushes German cockroaches out of hiding places and kills them. Zone Guard, Pro Ant, Roach & Crawling Insect Blaster should be applied from a height of 15 cm at the rate of 5 seconds per linear meter.

## **CRACK & CREVICE TREATMENT:**

Use Zone Guard, Pro Ant, Roach & Crawling Insect Blaster with the supplied actuator and injection tube. Inject into cracks and crevices or void spaces where insects may be harboring, living and breeding. Place injector tip into cracks, crevices, holes and other small openings. Treat crevices of baseboards, around door and window frames, cracks and crevices in cabinets and pantries, and openings around pipes and sinks.

Ants, Cockroaches (American, German, Oriental), Crickets, Sowbugs, Spiders, and Brown Dog Ticks: For use indoors, direct spray nozzle so that spray contacts insects directly, if possible. Spray into cracks and crevices and other hidden surfaces where these pests are hiding, such as under sinks, behind stoves and refrigerators, around plumbing service and other areas where these pests are seen. NOT FOR BROADCAST OR SPOT APPLICATION. Repeat application as necessary when pests are seen, but not more often than once a week. Ventilate treated rooms after application. Do not apply to surfaces which are accessible by children. Thoroughly wash all exposed surfaces such as areas of baseboards, floors and cupboards that are incidentally sprayed during crack and crevice application.

Stored Product Pests (sawtoothed grain beetle, confused flour beetle, rice weevil): In the kitchen, remove and inspect stored food products. Remove infested packages and seal in plastic bag to prevent reinfestation. Discard bag in garbage. After removing all food packages and shelf liner, spray visible pests, cracks, crevices, and corners of pantry, cupboards, and storage areas. Allow treated areas to dry. Thoroughly clean all food contact areas with potable water before putting down new shelf liner or returning containers to shelves. Repeat treatment as necessary, but not more frequently than once a week.

### PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Harmful if absorbed through the skin. Avoid contact with eyes, skin or clothing. Remove contaminated clothing and wash before reuse. Avoid breathing vapors or spray mist. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Wash thoroughly after use. DO NOT TREAT PETS WITH THIS PRODUCT.

## FIRST AID:

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If inhaled, remove victim to fresh air. Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice. If ingested, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.
