# **PRECAUTIONS**

Potential skin sensitizer. Causes eye and skin irritation. DO NOT get in eyes or on skin. Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing dust and contact with skin or eyes. The active ingredient ethalfluralin may cause skin sensitization reactions in certain individuals. Wear goggles and protective clothing such as coveralls, a long-sleeved shirt and impermeable gloves when handling this product.

#### **FIRST AID**

Take container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person.
