DIRECTIONS FOR USE

How to Apply: DO NOT apply as a space spray or broadcast application. Apply as a crack and crevice or spot treatment only to kill pests listed on this label. Spot application is localized to a surface area not more than 0.2 m². Spots are not to be adjoining. The combined area of spots is not to exceed 10% of the total surface area of a room. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

Restrictions: DO NOT apply to any body of water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Avoid application of this product when winds are gusty. DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment. DO NOT apply when people or pets are present. DO NOT allow people or pets to enter treated areas until sprays have dried. DO NOT allow spray to drip or allow drift onto non-target surfaces. DO NOT apply to people, pets, livestock or sources of electricity. DO NOT apply to furniture, mattresses, linens, toys or clothing.

DO NOT apply to overhead areas or in confined spaces (for example, indoors in attics, crawlspaces, small storage rooms, closets; outdoors to eaves, soffits). When applied indoors, ventilate treated areas after application by opening windows and doors, or using fans where required to aid in the circulation of air. DO NOT apply as a space spray or broadcast application.

General Directions: SHAKE CAN WELL BEFORE USING. Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vapourize into cracks and crevices for insect control. Treatment must only be repeated if pest problem persist or reoccurs. Provide adequate ventilation after indoor use. KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY”

INDOOR USE:

To Control Spiders, Sowbugs, Earwigs, Cockroaches, Crickets, Millipedes, Silverfish, Ants and Carpet Beetles: Thoroughly treat indoor building surfaces in hard to reach areas including cracks, crevices in walls, floors and ceilings; along and behind baseboards; walls behind and floors beneath appliances (e.g. refrigerators and stoves) and furniture (shelves, drawers, cabinets and storage units); around garbage containers; localized areas of floors and floor coverings; and points of entry (e.g. around windows and doors). Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

To kill Brown Dog Ticks and Fleas: Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, window and door frames and localized areas of floor and floor coverings. For effective flea and tick control indoors, clean any area used by the pet. Cleaning the areas includes vacuuming floors, carpets, furniture, etc. (discard vacuum bag after use) and washing the pet's bedding, living quarters, and surrounding area. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. Do not spray pets with this product. Only treat pets with products specifically registered for use on that type of pet.

OUTDOOR USE:

To Kill Spiders, Sowbugs, Earwigs, Cockroaches, Crickets, Millipedes, Ants, Fleas, Brown Dog Ticks, House Flies and Cluster Flies: For use outdoors on the exterior surfaces of buildings, garbage cans and on patios, porches and decks as a spot treatment. Apply to the outside surfaces of foundations, light fixtures, eave troughs and under eaves and places where listed pests enter (e.g., screens, doors, window frames). This product may also be applied to garbage cans and localized areas of patios, porches and decks.

[Application to vinyl and aluminum siding (particularly lightly colored, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Always pre-test a small inconspicuous area to be treated, for colour fastness and staining. Pre-test siding. Evaluate 30 minutes after test application for potential staining. Never apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of day. Do not apply to tapestries, wall paper or similar materials that may stain.] Cluster flies and house flies will be killed when they land on the treated surfaces. DO NOT treat soil, turf or other plants adjacent to the treatment site. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through the skin. May cause skin and/or eye irritation. Do not get in eyes, on skin, or on clothing. Contents under pressure. FIRST AID

TOXICOLOGICAL INFORMATION
